SASSPA Teachers Mutual Bank Study Scholarship for Work Integrated Learning

The Teachers Mutual Bank and SASSPA have formed a joint partnership to financially support administrative staff in their studies to develop leadership skills and meet the challenge of changing work practices in education. To be eligible to apply please refer to guidelines and application form attached.

- Applications should be submitted on the SASSPA Scholarship Application Form ONLY. The next round is open for study in 2017. Completed forms may be emailed or posted.
- Applications may be lodged for study now being undertaken or planned courses in 2017. Each applicant will receive a letter of acknowledgement and successful applicants will be advised.
- All applications will be reviewed and assessed by a panel of SASSPA Scholarship Sub-committee members and a Teachers Mutual Bank representative.
- SASSPA is seeking to support SAS staff financially to alleviate some of the financial pressure which is often associated with external study.
- Course of study must be relevant to ***developing and enhancing leadership positions*** in the school environment.
- Successful applicants will be eligible for **up to \$2,500.00** to offset fees and costs related to the course upon proof of enrolment and meeting the guidelines.

Guidelines:

- Applicant must be a permanent employee of the Department of Education NSW and a financial member of SASSPA.
- Proposed expenditure outline, including cost of study, enrolment fees, and other incidentals should be submitted to be assessed by the Scholarship Review Committee. Evidence of educational outcomes associated with planned study must be provided.
- The scholarship is open to any discipline. Preference will be given to qualifications that
 - provide leadership and management capabilities
 - develop personal growth and strategies to manage and lead teams
 - expand communication skills
 - provide the greatest benefit to your school role.
- SASSPA and Department of Education run courses will not be considered.
- Study course must be relevant to developing leadership positions in the school environment to provide quality education for students. Please provide evidence of educational outcomes associated with planned study.
- Progress report must be provided to the Scholarship Sub-committee each semester.
- Successful applicants will be required to submit an evaluation on completion of the course to the Scholarship sub-committee. Your report may be used by SASSPA and the Teachers Mutual Bank to promote Scholarships and feedback will be available to SASSPA members through NetLink magazine.
- SASSPA will not be responsible for the cost of casual relief.
- Applicants may also be eligible for SASS study assistance for up to three hours paid leave per week. Full details are available on the High Performance website or contact Robyne Russo, SASS Professional Learning Coordinator.
